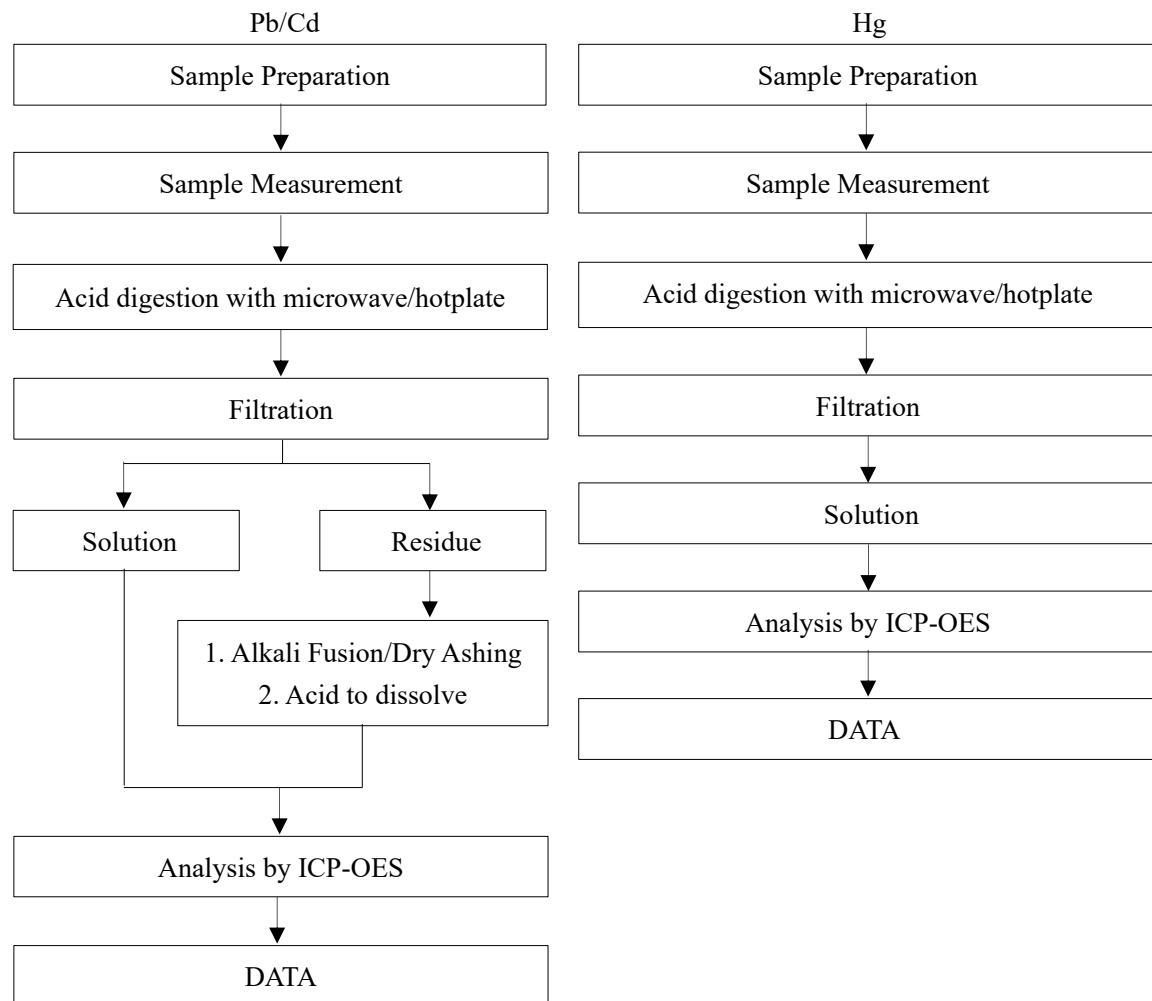

Test Flow Chart of Lead, Cadmium and Mercury

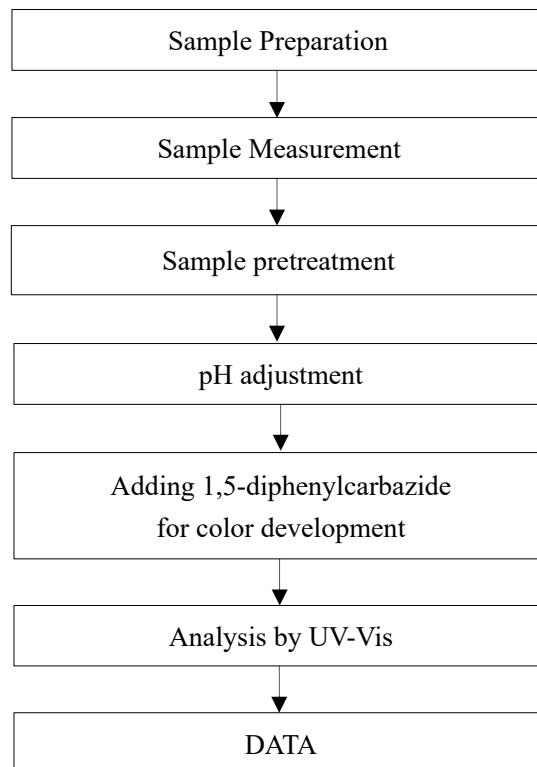

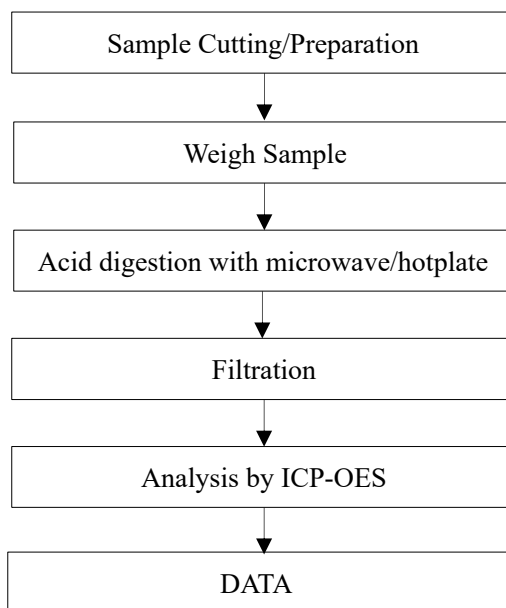

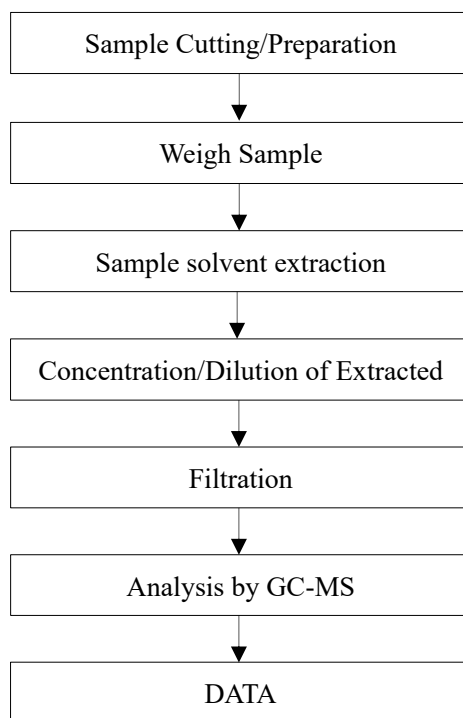

Test Flow Chart of Pentachlorophenol (PCP)



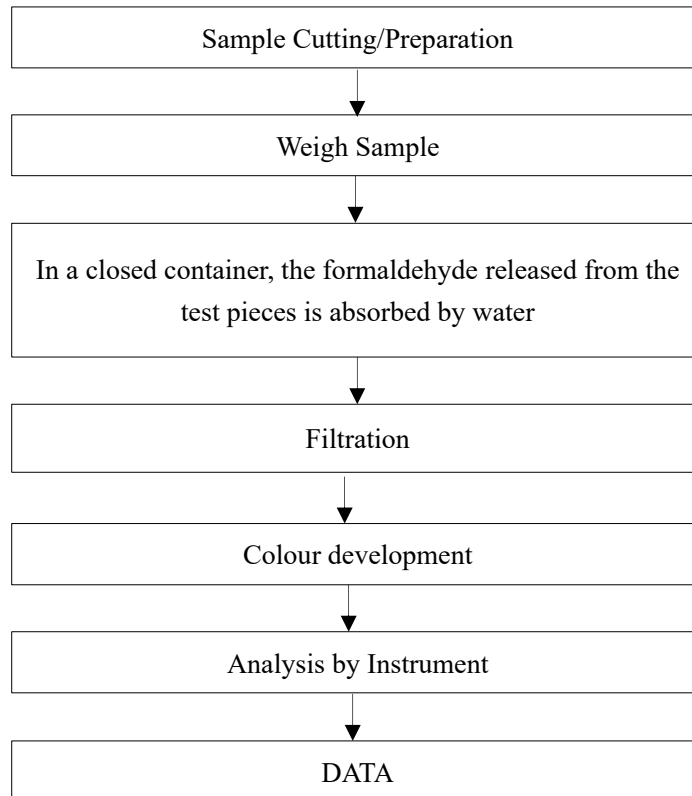
