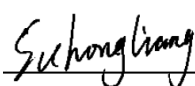

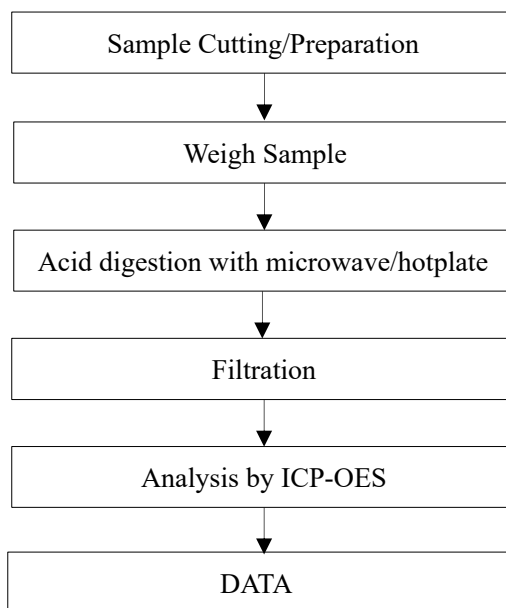

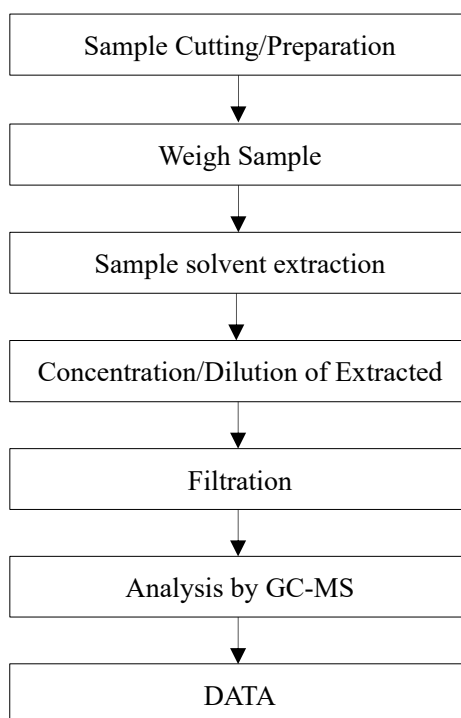

Test Flow Chart of Phthalates



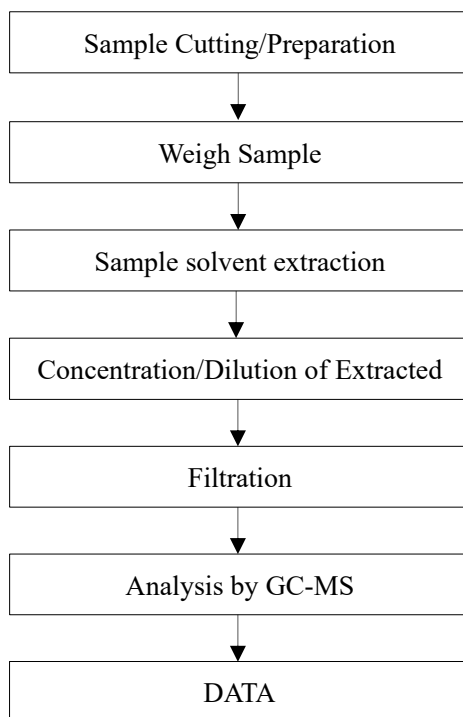
